



# 2024 Program Outcomes

### **Supportive Housing Services:**

- 76 Adult and Children participants
- 24 Families, 28 parents
  - 4 families had 2 parents
- 48 Children
  - 4 children over the age of 18
  - 31 children ages 6-18
  - 13 children ages 5 and under

### Participants by Race:

- 55 African American
- 1 Biracial
- 20 Caucasian

### Safe Space at Sisters Place:

- 200+ visits from housing and community clients
- Includes resources, referrals, and support
