THEY ALSO HAVE TO HAVE CUSTODY OF DEPENDENT CHILDREN OR BE AT LEAST SEVEN MONTHS PREGNANT TO BE ACCEPTED. CLIENT HOMES ARE SCATTERED-SITE IN THE HILLTOP AREA OF PITTSBURGH, PA. ACCEPTANCE INTO THE PROGRAM IS SUBJECT TO AN INTAKE INTERVIEW.
